#### **Agricultural Report**

Hi Brothers and Sisters,

What a new world we have opened into with a pandemic. This past year has shown how centralizing our food production to large factories may work for cheap foods, but are easily broken down when disease is included into the equation. While trucking and workers couldn't work, fields full of vegetables were not able to be harvested and trucked meaning large gaps in farmers budget and empty shelves in the markets. Butchering quickly stopped causing meat shortages. Without the Butchering factories running those people charged with providing the animals to them found a bottle neck causing millions of animals that were ready to go into the food chain to be euthanized and buried. All of which was compounded when the government suspended some rules causing cheaper unregulated meat to be imported into the USA and get a USDA stamp on it and put into the markets.

On the bright side with everything going on seed companies and small businesses like Garden and Grain stores found themselves in a panic as more and more people purchased supplies to grow their own food. From Seeds to Baby chicks to Grain sales went wild. People in fear of a loss of food and starvation started buying everything. Local animal farmers found a demand that they just couldn't fill. The State helped set up a truck up of pigs from out of State dropping the price of pigs in the state but also bringing in animals that are factory farmed and have no real immune system causing health problems with the animals that came up, some farmers having to put them down as they struggled with having to be on the ground and fields. Meanwhile the local USDA butchering companies already having waiting lists for butchering found their list going from 3 months to 14 months before they can service the local animals. Over flow going to small non inspected custom butchers.

On top of all of this, this year the State included poultry on the list of animal trespass please read the Agriculture brochure for more information. This law was originally made for male animal trespass to make it illegal to allow your male animals to run around and do un intended breeding's, but in 2015 they changed it and its intent to make it illegal for your Cow, Sheep, Goat, Pig, or horse to trespass onto someone's property, now it includes poultry how sad is that?

Now as the year is coming to an end we have found that the drought that covered NH during the spring and summer has greatly impacted hay production making it even harder this winter to have stores for animal feed this winter. I think we are all going to be excited when 2020 is completed and we start moving forward with the new year.

Thank you, worthy Master, for appointing me to this position I have greatly enjoyed it and hope the Grange keeps its Agricultural history alive.

- Croydon and Riverside Granges are behind in quarterly payments and reports and will be unable to vote at State Session unless the past payments and reports are submitted.
- Membership lists for Henry Wilson and Croydon Granges will be sent to the Secretaries of the Granges receiving the transferring members.
- All packets and materials for state session are printed, stuffed, packed and ready for session.

Motion was made by Wilber Heath and seconded by Tricia Taylor to accept the report of the Secretary. Vote was favorable.

Treasurer Report

• Income and Expense reports were presented and reviewed.

Motion was made by Mark Collins and seconded by Chris Heath to accept the report as presented. Vote was favorable.

Old Business:

- Granite Grange Hall ~ No up-date at this time.
- Modem Cabinet ~ Chris is taking care of this and hopes to have it taken care of soon.
- HVAC System ~ cleaning and annual maintenance of the system has been completed.

- Shed ~ The shed has not yet been purchased but will be and installed during the cleanup weekend in the spring.
- Pembroke Grange will be allowed to use the hall temporarily and can store the few stations that they have at the State range Building.
- State Grange Policy Book ~ this has been in process for several years and it has been requested that the completed selections be added to the website. Wilber will send this to the Webmaster for him to place in an appropriate place.
- The task sheet was reviewed and up-dated.

#### New Business:

- The Church has requested to make some improvements to the building with approval of the State Executive Committee and with a state representative present (painting the kitchen and bathrooms same color or our choice and at their expense). A motion was made by Chris Heath and seconded by Tricia Taylor to allow this. Motion was made by Wilber Heath and seconded by Mark Collins to amend to consider this request following a four month occupancy from the church. Amendment was voted favorably. Amended motion was voted favorably.
- Discussion was held on how some renters are leaving the State Grange building after events. Items are being taped to the ceiling and walls and not all tape is being removed. Talked about adding a cleaning charge to the rental agreement and if the building is left in acceptable condition the fee would be returned and if not, we keep the fee. Jerry will forward the contract that Hudson Grange uses for their rentals and adapt to State Grange is approved.
- Custodial services at the State Grange Building was discussed. Now that the hall is being used more consistently mostly by the church, it was felt that our current arrangement may not be the best option for the more frequent cleanings and that we possibly look into finding a person or group local who can be available following events.
- State Historian, Richard Patten requested the purchase of a Grave marker and Flag for Past Stet Master John Saturley. Motion was made by Beth Merrill and seconded by Tricia Taylor to approve the purchase of this. The vote was favorable. The \$146 cost will be taken from the Historian budget.
- Lower Intervale Grange ~ State Master Heath reported that Lower Intervale Grange has sent him an E-mail stating that they voted to give up the rights to their Grange hall and giving it to the New Hampshire State Grange. After some discussion it was decided that Tricia Taylor will reach out to the Grange and research what steps need to be followed and will report at the next meeting. Chris will send a letter to the Master and their Deputy informing them of the steps that are currently happening
- Jeremiah Smith Grange recently took in eight new members and have several more interested.
- National Grange ~ State Ceres Kerriann will not be attending National Session so a motion was made by Tricia Taylor and seconded by Beth Merrill to send Wilber Heath in her place. The vote was favorable with two abstentions.

• State Session Banquet ~ The number of tickets sold for the banquet doesn't meet the minimum required by the Hotel so the NH State Grange will be responsible for the discrepancy. Motion was made by Chris Heath and seconded by Tricia Taylor to pay the discrepancy in banquet ticket sales. Vote was favorably.

- 31 New members have been initiated this quarter, giving NH a net gain for the second consecutive quarter,
- Membership total is currently 1159
- New Hampshire currently has 43 active Subordinate Granges following the consolidations of Croydon Grange with Park Grange, and Henry Wilson Grange with Centennial Grange.

Treasurer's Report:

Income:

- Withdrew \$5,000.00 from principal in Oct. to help cover expenses.
- Cashed in the savings bond from White MT. Grange \$2,464.24.
- Received \$1,200.00 donation for GSG in January, Misc. \$500 from Richardson fund for youth travel, \$500 from Grange Advocacy, added in uncashed Junior check \$250 from last June.

Expense:

- Misc. \$600 each for Jeremiah Smith & Wingold renewal applications.
- Youth travel to national \$500, State session room for membership winner, Ida Hutchins \$239.70, National session 2019, delegate travel \$882.60, State building chimney repair \$3,865.

Other items:

- 1. Jeremiah Smith has been reinstated as a nonprofit with the IRS
- 2. Wingold is taking longer, IRS needed more info, working with Don Ross, hoping this will be completed soon.
- 3. This year nonprofit renewal with State of NH is due, \$25.00 per Grange. I have not as yet received post card for Rochester Grange.
- 4. Sent the required forms for property tax exempt status to Hooksett (State Grange building) & Milford (Granite Grange). Still need to do Granite State.
- 5. The 2019 taxes were filed on time. If anyone would like to see it, I will bring it to our next face to face meeting.
- 6. Cashed in White Mt Grange savings bond.

Motion was made by Wilber Heath and seconded by Mark Collins to accept the report of the Secretary and Treasurer. Vote was favorable,

Old Business:

- 2020 State Session: The contract with the Best Western PLUS Portsmouth has been signed and the deposit made. Guest room rats are \$109 plus tax,
- Loan request from Meriden Grange: The request was granted and a certified letter was sent to the Master with specification of the conditions of the loan. No reply from Meriden Grange requesting the amount, The State Secretary will send a letter asking if the loan is still needed.

The vote on the amended motion was favorable. The State Secretary will send a letter to inform the Pomona and Subordinate Granges of the decision.

New Business:

- 2021 State Session: Both Concord Hotels are already booked for the date we are requesting. The Best Western Keene has been contacted and waiting for a response. It was also suggested to look at a new facility in the Lebanon area.

Despite all of these, I have continued to read State Grange Journals and find interesting tidbits here and there. I have a State Grange Historian Blog on Facebook which I write thoughts or memories I have of past State Grange Sessions, members who have passed away, or thoughts of special nights etc. I appreciate the remarks people have made when they have read them. I have over 100 followers of this blog.

It doesn't seem possible that the Grange continues to make a difference whether it is through agriculture or community projects. The Grange can make a big difference whether it is in the Legislature, community, or a person's life. I have received several telephone calls or emails about people asking about certain Granges who have closed or if they are still active. It is amazing how many people today are interested in the history of this great organization. Some of these included Madbury Grange, Cardigan Grange of Alexandria, Dover Grange, Strawberry Bank Grange of Portsmouth, Plymouth Grange, and Warren Grange to name a few.

I have done a lot of research on these and hopefully gave them the information they needed. I have also received telephone calls from funeral directors who had someone that passed away and listed as being a Grange member. However, they didn't list the name either because the family was not aware of the name or knew little about their involvement.

I also tried to locate members who were very active in the past but somehow got lost in the shuffle. In some cases, their Grange had closed and no one knew where they went. Recently, I was asked to try and locate grandparents who belonged to Ezekiel Webster Grange of Boscawen. They were looking for photos the Grange may have had. I found the grandparents but I have no photos of them.

I tried to locate Peter Brown and his family who were very active in the Grange from Greenfield. Peter was a well-known singer in the State Grange Talent contests or soloist for the Sixth Degree in the late 60's and early 70's. Many thanks to Charlene Hooper for helping to locate this family. I was saddened to find out Peter had died last year in Delaware. He was only in late 50's and it was a logging accident. His mother Eleanor Brown along with his two sisters had moved to Delaware. Eleanor had a fatal car accident in Virginia, she was the passenger. Her two daughters still live in Delaware and are members of the Grange in that state.

Elaine Nichols passed away a few years ago but it was never reported. She served as a member of the State Youth Committee and State Membership Committee. She is a Past Master of Pilot Grange, Androscoggin Grange, Androscoggin Valley Pomona Grange. She was a very active member in the northern sector of the state.

Carolee Barrett passed away this year and I was very surprised. I first met Carolee and Roland Barrett when they were named State Grange Young Couple of the Year. #### Secretary's Report

Secretary Tara Sad presented the minutes from the 2018 Grange Foundation Annual Meeting:

Tara Sad moved and Bob Haefner seconded a motion to accept the Secretary's Report as filed. The resulting vote was unanimous.

He noted that this is 2019 marks the 10<sup>th</sup> anniversary of the establishment of the Grange Foundation. He then read his President's Report:

#### **President's Report**

Pres. Tetreault then presented his President's Report:

In doing some research for this report, I have determined that this is the 10<sup>th</sup> Anniversary of the incorporation of the Grange Foundation. So Happy 10<sup>th</sup> Birthday, Grange Foundation!

The Foundation was founded on the basis of a bequest from Clarence Sprague, who, in the 1930's, received a scholarship from a local Grange in NH. Sprague was so grateful for that support in his early years from the Grange that he wanted to return the favor and remember the Grange in his last will and testament. The Grange, being a 501c8 organization rather than a 501c3 that receives tax benefits, spurred the NH State Grange Executive Committee to look to establishing a foundation to accept and manage the bequest.

What are the goals of the NH Grange Foundation? To support students going on to receive an education beyond high school. The Foundation serves an important function for Community Granges across the state. The Foundation is be able to accept monies on behalf of local Granges, allowing the donor can receive a tax benefit. Does your Grange look for donations in the Community? Right now we have one Community Grange that is using the Foundation to help with a major restoration of their Hall. I encourage you to talk to the members of Antrim Grange about how they are doing this. It could be a major benefit to your Grange.

I want to thank the members of the Foundation board this year for bearing with me. As many of you know, in 2014 I stepped away from Grange officers' leadership because of the state of my mom's health. Many of you may not be aware, but my mom's health took a serious downward spiral starting at Christmas time of 2018, and it came to head in May of 2019, almost resulting in her death. We were lucky, the right doctor walked into her room on that first Sunday of her hospitalization, asked the right questions, and we were lucky to have the right answers. After spending two weeks in the hospital, and six weeks in Applewood Nursing home in Winchester for rehab, our family is lucky to have her recover and return home in a much healthier state that when she left home in May. She

will undergo several operations in the coming months, which we hope will ensure a better quality of life for the future.

Jozi Best moved and Dave Babson seconded a motion to accept the President's Report as submitted. The resulting vote was unanimous in favor.

#### New Business:

#### **Election of Board Members whose terms expire:**

Andrew Savage moved and Sandy Salo seconded the motion to elect those board members whose terms expire to another three year term. They are John Porter, Bob Haefner and Tara Sad. The resulting vote was unanimously in favor.

I would like to thank the Legislative Committee members for their service to the State Grange and its Legislative Department. Jozi Best, Tara Sad and Jim Tetreault a heartfelt "Thank You".

This past year was the 4<sup>th</sup> or 5<sup>th</sup> National Grange Fly-In to New Hampshire for the "First in the Nation Presidential Primary". It was again an honor to host this once every four-year event with Sister Tara Sad and thank both Jim and Jozi for their contribution to putting the event on. I would be remiss if I did not also thank Chris Heath and Centennial Grange for a wonderful Breakfast that they put on at the State Grange building for the participants. We had participants from as far away as the State of Washington and our attendees included our National Master, Betsy Huber. It is always a privilege hosting the Master and four others representing our National Organization. We learned a lot about the Presidential Primary, got to work on campaigns, learned a little about how NH government works and even toured the Mill Yard museum at the Amoskeag mills. Also, in how we are allowed to meet, how we feel, how we act, how we treat each other and how we survive from day to day. Starting at the local levels, we need to rise to the occasion, change our direction and get back to our foundation or we will no longer exist. I for one do not like the idea of this organization dying and because of that passion that I have, I am going to do all I can to keep it alive. I challenge you to look deep in your hearts and decide if you do as well. It is going to take a huge concerted effort by all of us, everywhere around the nation to change our direction and keep this organization alive.

I want to commend all the Granges that have been able to adapt to our "new world" and have held their meetings by using the conferencing technologies, like Teams, Meetups and Zoom, that are available today. During this time of social distancing and gathering restrictions it's important that we find other ways to stay in touch, conduct our meetings and do the business that needs to be done. Also, I applaud those Granges who have now started meeting back in their halls. They are the true champions over this time of uncertainty. They have defied the odds and taken up the challenge to continue. We could all learn a lesson or two from these Granges. I feel like we have reached a turning point in our current situation and these are the first steps to recovery from the pandemic shut down. The Granges in New Hampshire, which currently have a large majority of people who fall into the high-risk category for catching this virus, must adapt now. This reality makes things difficult for most Granges to get back to normal meetings but we need to do this as soon as we can. Some if not all of the members in this age bracket are afraid to even leave their homes, never mind going to a meeting at the Grange hall. All I can say to these members is we love, care and want you to stay healthy, safe and secure until it is safe for you to join us again.

For those Granges that are still not meeting it is important to reach out to each and every one of your members and keep in touch with them. This is one of the reasons most of us have joined this organization and it's important to keep this fellowship. If your Grange is meeting back in your hall make sure to take every precaution to provide a clean and sanitized environment. Let your members know what measures have been taken to make the space safe for them. If you think you can meet virtually via zoom, the State Grange now has an account and can provide your Grange with the ability to use this platform. It will take some training and help from someone who knows how to use the software but once members learn how to use it, they will see that it is a helpful tool.

If your Grange is interested in utilizing this tool, contact the Chairman of the Executive committee to reserve a time for you to meet. Let's embrace this challenge, meet it head on and work to improve our current situation. We as Grangers need unity more now than ever before. We should be finding new ways to be more active in our communities and providing outreach to our neighbors through physical labor, education, financial assistance as well as many other areas where Grange members have experience and resources. They need us and we need them. It is a symbiotic relationship that will benefit both parties.

Membership continues to be an ongoing issue for some Granges. This challenge is affected by many outside and inside interferences. Negativity, disparaging, bullying, talking down to one another and other factors are causing or contributing to our decline, reduction and loss of members in our local Granges. There are still many "cancers or viruses" in our halls that need to be resolved or removed. If you don't know anyone in your Grange, that fits this label, that person just might be you. You could be the negativity that forces members to not come to meetings, leave the Grange and never come back or cause them to have outbursts that disrupt the meeting. You may be the bottleneck in the membership recruitment process and need to re-evaluate what you say or do to your fellow members. We all need to remember that it takes all of us to make a Grange work and just because something hasn't worked in the past doesn't mean it won't work now. We should all be able to agree to disagree, work together for the good of the order and remain friends despite our differences. Remember that our actions affect not only the person that we are having the issue with but also other members around us. People subconsciously process what is happening and decide whether they want to stick around or get lost.

We are losing younger members at an alarming rate because they have no interest, their ideas are often rejected or there is no mentoring coming from the seasoned members. We need to reverse this action and approach them with an open mind and heart. Try to understand that they were not brought up the same as most of us. Listen to their ideas and help them instead of beating them down. These are the future of our Grange, our Grange leaders of tomorrow and if we push them

out, we will have no future. Welcome them, mentor them, teach them and make them feel important because they truly are important and ultimately our future. They say that sometimes you win some and sometimes you lose some but right now we are losing pretty badly and we need to start winning again. It is said that it only takes a little faith to move a mountain and this is a good thing because a little faith is all we have right now. We need to overcome a large mountain that is in front of us and we need more Do'ers. Let's all do a better job at being a part of the solution and not a part the problem.

Communication is still an issue in our organization. I personally feel that this year has been better but that is a result of not being able to do much. I think that communication from the State Grange has improved some but the reverse from Subordinate Granges has fallen off some.

Granges need to realize that when they have questions about procedure, the bylaws or how they should do something, they need to reach out before they take action. A prime example of this happened this year when two resolutions, that were submitted to State Grange, were publicly retracted through our Grapevine. Individuals should not be making decisions for an entire Grange and members from other Granges should not interfere or dictate what another Grange should do. All questions should first, be directed through the Pomona, then State Grange. We are the leaders of the organization and know the proper way things should be handled. Just because an individual has been a member for a long time doesn't mean that they know the current and proper way to do something.

Communication is a key to success and keeping the Grange work within the bylaws of our order is the responsibility of the State Master. She/He is the officer that makes all rulings on the State level and if they don't know how something should be handled, they have the National Master to guide them and make the ultimate decision. Subordinate and Pomona Granges should make the decisions that pertain to their local Grange and if they have questions, they need to start with their deputy. When possible, these decisions should be made by the Grange body, not individuals. Our bylaws state that the executive committee, in conjunction with the Master of the Grange, makes the decisions of the Grange when the Grange is not in session or between meetings when the need arises. We need to follow this instruction and if they cannot come up with a result, that action should be held over until the next regular meeting or when a special meeting can be held to discuss it.

I want to wish the new Master and other officers of the State Grange the best of luck with their terms and let them know that I will support them in any way that I can. My passion and love of this organization is something that I have always tried to exude/portray in everything I do. When I started as your State Master six years ago, I made a goal to clean up the decaying branches of the order and try to leave the Grange in better shape than when I got it. I personally feel that I have done this but unfortunately there is still more work to do.

I encourage every Grange to "work" on making their Grange stronger so that we don't have to lose any more of our Granges. My goal was not to leave a legacy, because it is not just one person's accomplishments that make an organization succeed, it takes the work of many hands, to ensure that the Grange will be strong and survive. Let us promise each other to rise up and make a difference in this ever-changing world because let's face it, ultimately it is not what we do personally but the Grange that should matter to all of us. We can rise up from the dust just as our founders did over 150 years ago and make this organization the powerhouse that it once was again.

In closing I would like to take this opportunity to thank some special people who have mentored and helped with the work that has been accomplished over the past six years. Kerriann Nightingale for being a sounding board, remembering tasks that need to be done, making runs to the store to get things I needed or forgot, taking care of lunches for Deputy School, listening to me when I was experiencing frustrations and a countless number of other tasks that I asked of her.

Wilber and Jane Heath for bringing me into this world, raising me to be the man that I am, keeping me grounded, helping with the little things that I needed and always being that shoulder to cry on when things were difficult.

Beth Merrill, Dan Bascom and Jim Tetreault for sound advice as past State Masters when I had questions about procedure, how things should be handled, providing suggestions and listening to my ideas of things I wanted to do.

Edward Lutrell, past Master of the National Grange for being one of the greatest mentors a State Master could ever have. Dick and Debbie Patten, Lois Enman, Linda Phelps, Robert Haefner, Steve Tracy, Norman Brandt, Joann Brandt, Kathy Yardley, Joyce Martin, Jim Tetreault, Gloria Davis, Sarah Leclerc and Matt Collins for agreeing to help me as directors. Andrew Savage for jumping in with both feet to tackle the role of General Deputy, helping come up with the Grange requirements for Instructions and Inspections and for willing to host me for our meetings.

When we left State Grange in Lebanon last year, we were very hopeful and optimistic in our plans for a region wide membership conference. From the 2017 Resolutions Committee Report Resolution #1 Submitted by: Hudson Grange #11 Subject: Future of Pomona Granges in New Hampshire

WHEREAS, the number of Pomona Granges in New Hampshire have declined from 11 reported in 2013 to 8 as reported in 2017. Showing a loss of 3 Pomona Granges.

WHEREAS, the number of members have gone from 680 to 473 in the same time period leaving the State of New Hampshire with a loss of 207 members.

WHEREAS, interest and involvement in the Pomona Grange in New Hampshire has declined preventing Pomona Granges from properly conducting meetings and conferring the Fifth Degree. WHEREAS, the distance members need to travel to attend a meeting may be a deterrent for them to be more active

THEREFORE, BE IT RESOLVED, that the Pomona Degree be retained as a requirement of membership to the Sixth Degree, and be conferred by a Fifth-Degree team comprised of members from Pomona Granges at a time and place prior to the annual NH State Grange session for the next three years with the expectation of a gain of 50 "NEW" Pomona members.

BE IT FURTHER RESOLVED, that if this resolution passes, and the expectation is not achieved, ALL Pomona Granges in NH will be closed as of October 31, 2021. All assets of Pomona Granges effected will be held by the State Grange in an account while a fair and equitable use of the assets can be determined.

**Deliberations:** 

All 9 Pomona's were represented at the meeting. Differing of opinion as to what to do. No decision has ever been made Jerry Leclerc is trying to force that discussion. If nothing gets accomplished, then they will go away.

There are some states with no Pomona's. Some with only one Pomona, whose main duty is to do the 5<sup>th</sup>. Monthly to quarterly meetings. Attendance is terrible. No new members. Total of 12 at Pomona meeting (of 50). 40 never come.

Unanimous vote in favor. Can't do any harm. It's giving us an opportunity to keep the Pomona's, all you have to do is grow numbers. If you don't, they'll go away. 2-0 voted in favor of the resolution

The Journal of Proceedings for the 146th Annual State Grange Session was completed and ready for distribution in early January. Having the journal completed quickly remains a priority to me so that those wishing a copy can receive one while the session is still fresh in their minds. As always, the Journal is placed on the website for anyone to see. If a Grange wishes to have a hard copy sent to them all they need to do is request one. If a member would like a copy one will be provide to them for the cost of printing and postage.

Near the end of each quarter, a packet was sent to each Pomona and Subordinate Secretary with information for the members, as well as the usual report forms. I can't stress enough how important it is to complete the reports and send them in on time. As I have already reported, this past year has been challenging, and reports were not always on time. Thankfully the Secretaries remained diligent and submitted reports when they could. As of June 30<sup>th</sup>, all granges are in good standing with reporting and dues payments.

By doing this the awards can be sent in a timelier fashion as some information is needed when before I send the request to National Grange. Unfortunately, there have been some delays in receiving swards from National Grange due to modified work schedules at National Grange because of the pandemic. Hopefully this will improve.

State Session is once again approaching and with that comes the preparations associated with it. Unlike previous years, preparing for this year's session was especially challenging due to the pandemic. Many changes needed to happen to be in compliance with the guidelines outlined by the CDC for social gatherings.

- Condense session from a three-day event to a one-day event.
- Limit attendees to just State Offices and Delegates
- Offer pre-registration of Delegates

- Purchase and provide personal protection supplies (masks, hand sanitizer.....)
- Providing lunch so that all attendees remain on site.
- All materials distributed could be taken

As we all know, these plans were quickly put on hold due to the pandemic that is currently restructuring our lives.

As a result of the shutdown imposed by the Governor, in mid-March, we were not sure what effect this would have on our session. As the months went on with no sign of the pandemic being over and the Hospitality industry suffering due to the restrictions imposed on social gatherings. It was decided to condense the session to a one-day event and invite only State Officer, spouses and Delegates.

Many calls were made to the hotel to re-vise the contract, ask about accommodations, and food service. Fortunately, we were able to still have the space and guestrooms at the original prices. It was voted by the State Executive Committee, to provide a lunch at session for those attending at no cost to them. This was done in an effort to keep members safe and in one location also due to not knowing what if any restaurants would be open.

Because of restriction on social gatherings many changes had to be made in order to keep or members safe and to stay within the guidelines set by the CDC.

- Registration: For the first-time pre-registration was offered and proved to be beneficial in not only complying with social distancing, but also by streamlining the check in process at session.
- Meeting space: Again because of the guidelines imposed on spacing, we worked with the hotel to arrange the meeting space so as to keep members at the recommended distance. This was done by providing a table for each Grange represented.
- Session Materials: All session information was placed in folders so that the delegate could take everything with them when the session was over.
- Personal Items: A bag containing bottled water, tissues, hand sanitizer, ballots, and a pen has been provided at each seat.

As I close this report, I would like to thank any one who has assisted in making this day possible. Many changes needed to be made and as a result some of these may now become standard in future sessions. I would especially like to thank all present in the room for placing confidence in me to ensure that we have a safe session, some may not be happy with some of the changes but, just remember that they were done for the benefit of our members.

Looking forward to meeting with the entire membership at the 2021 State Session hopefully in the Keene NH, area.

### **State Grange Building**

Following State Grange session last year, the State Grange Building continued to be rented by Liberty Bible Baptist Church and various Nepali groups intermittently. February was a bit more exciting as the State Grange hosted a delegation of Grangers from around the country. Our State Master and Centennial Grange prepared and served breakfast to the participants of the 2020 National Grange Primary Fly-In at the building. Later that same day the Junior and Youth departments put on their annual winter rally. Also, in February Crown Chimney of Hooksett installed a new Class-A chimney at the building and arranged to have the roof and the back outside wall worked on since the new chimney is quite different in material, size, and shape from the old one.

For the third consecutive year the State Lecturer had planned three craft weekends to be held at the State Grange Building. The first two were held in January and March. Soon thereafter, the world changed and the Executive Committee found it necessary to close the building in response to the government's attempts to quell the spread of the corona virus. This was a disappointment to the congregation of the Liberty Bible Baptist Church, which has been renting the hall two or more days per week since last fall. They requested to use our internet so they could hold virtual worship services there, but at the time of the request our service was not sufficient for that kind of activity. The hall was reopened in mid-May and their services resumed, presumably while observing proper social distancing guidelines. A new lease has been signed, including a raise in the rental fee and some added stipulations, so the church group continues to meet there on a regular basis.

The Grange craft weekends have resumed on a monthly basis since the building reopened. A small, core group assembles to work on personal projects as well as community service projects such as Quilts of Valor, no-sew fleece blankets for Nighty Night bags, greeting cards for charity, and a quilt to be raffled at the New England Grange Building at a future Big E. We look forward to the day when the pandemic is behind us so that we can spread the word and invite all members to join in the sharing, learning, and fellowshipping that happen during this event. This is not a closed group, but for now, it is not a widely advertised group.

Some members of Hillsborough County Pomona as well as State Master Chris Heath and Wilber Heath, State Executive Committee member, held an outdoor workday at the hall in May. The front flower beds were cleaned out and weeded, a big task as they have become quite overgrown and neglected in recent years. Annual flowers donated and planted by Jerry Leclerc, have struggled all summer through the returning weeds and drought conditions, but today are thriving and looking beautiful around the flag poles. Brother Jerry Leclerc and partner George Perry have invested a lot of sweat equity in cleaning, clearing bittersweet, and mowing the grounds around the building. For the second year, a few tomato plants were added to one of the beds and have been producing an amazing amount of beautiful, heavy fruit. Look for a possible workshop on planting and staking tomatoes at the building next spring.

The Executive Committee has been exploring ways to improve our internet service in the building. A service technician came to the hall to install a new, higher speed modem. Upon noticing the massive amount of bittersweet that was growing up the pole and along the wires behind the building, he suggested that our service might improve if those invasive shrubs were removed. Also, the Executive Committee approved the purchase of a small tool shed for the property, but figuring out where in the back yard will be the best place to locate it has taken some time and imagination. Subsequently, a work day was scheduled in June with several State Officers working on a very hot day to clear out brush and trees along the wall at the back of the building. The result of this workday was a very large brush pile that accumulated in the yard, which has presented a challenge in finding a way to remove it from the property.

In early October, Harrison's Paving and Sealcoating was hired to do some work on the driveway loop around the building which had not received any fresh gravel in a very long time and was getting quite rutted. Since the property is lower than the road and very near to the river, water will probably always be an issue, but it is hoped that the new hard pack that was added, leveled, and rolled with a large machine will make a difference, especially with ice in the winter. In any case, driving around the building is a much smoother ride for now.

As you may have noted, improvements to the building this year focused on the outside. More painting is needed and yardwork can never truly be removed from the list, but things outside do seem to be moving in a positive direction. Inside, there is much to be done as well. The museum room is in need of some major cleaning and sorting of records and memorabilia collected by the State Grange from the remaining effects of Granges that have given up their Charter. The kitchen cupboards and cabinets need sorting and organizing, and maybe some new curtains would give all the windows a fresh look. There is no longer an Odd Fellows chapter that meets at the hall, so perhaps some of those oversized chairs could be relocated to new homes. It wouldn't take long to create a lengthy wish list for improvements that would enhance the usability of our hall. Some work on the lighting is definitely on the list.

The majority of this report was written by the worthy custodian who spends quite a bit of time at the building and between that and being on the State Grange Executive Committee is often more familiar with what is happening there. Your thoughts and suggestions would be welcome as we work toward making our State Grange Building a better home for us all.

# **Treasurer's Report**

Worthy State Master Chris Heath, Fellow Officers, Granges All:

This is my eighth year serving as your State Treasurer. Last year I presented you with another deficit budget. We ended the year with having to withdraw \$5,000.00 from principal. This was due primarily to chimney repairs on the State Grange building and expenses incurred on other Grange halls we are carrying.

As I started my first year of retirement, I was able to fine more time to complete treasurer projects I have been working on. First and foremost was getting Jeremiah Smith & Wingold Granges IRS nonprofit status reinstated. Jeremiah Smith's was restored in March. It took until August for Wingold's to come thru.

In February, working with Past Treasurer, Gail Turcotte, we were able to cash in the e savings bond we had from White Mountain Grange and added it to the defunct Grange account.

Concerning NH State Corporate Division, I completed updating name updates for all Granges (except two) to conform with the IRS. The cost for this was absorbed by State Grange and came out of fundraising funds totaling \$1,050.00. NH State Corporate Division is the department the handles nonprofit status for the State of New Hampshire. Each Grange must renew every 5 years at a cost of \$25.00, and this is the year to renew. On October 20<sup>th</sup> I accessed the state web site and found 32 Granges have not done this yet. This needs to be done by December 31, 2020.

On October 13<sup>th</sup> I completed the epostcards for all Granges, it takes about 8 hours to complete. I was able to complete this in time to give it to the State Secretary so they could be included in the program packet for each Grange. If for some reason you misplace it, I can send you a new copy. I am doing this for each Grange so you will continue to retain your nonprofit status.

As I have stated in the past, I do not receive all financial statements until about October 10<sup>th</sup>, this leaves me little time to complete my financial report for year end. All financial figures will be printed in the journal.

Spending the winter in Florida did not seem to hamper my work as your state treasurer. I was able to answer all questions and concerns that arose. Yesterday I stepped into the 22<sup>nd</sup> century, I established an online banking account for the State Grange. This will help me access the checking account and download statements much faster. I will also be able to change my address when we go back and forth.

I would like to thank each and every one of you for the confidence you have entrusted in me and thank you for asking me to serve as your Treasurer.

Again, we will be asking the Attorney General's office for assistance with this.

This last year the Trustees received only 1 request, the full amount of \$750 was granted.
